Terms & Conditions

1. All applications must be accompanied by payment of the appropriate course fee.
2. Following are the cancellation conditions for your camp, the amounts paid will be refunded to the participants according to the following:
 - Cancellations made until March 31, 2025:
100% of amount paid without any justification
 - Between April 1 and April 30, 2025:
50% of the camp fees paid without the need for any justification,
100% of the camp fees paid, if there is justification * for the cancellation
 - Between May 1, 2025 and June 6, 2025:
50% of the camp fees paid, if there is justification * for the cancellation.
 - From June 7, 2025: No Refund

* Accepted Justifications:

- Impediments to travel due to restrictions imposed by Governments or other legally competent entities
- The participant is prevented due to injury and/or illness. (with doctor report)
- Cancellation of Elite Training Camp by Sport Lisboa e Benfica and / or by indication of competent governmental entity

All justifications for cancellation must be confirmed by submitting a legal document confirming the reasons and clearly identifying their applicability to the participants.

Sport Lisboa e Benfica reserves the right not to accept justifications that do not meet the requirements presented above and that are not possible to clearly identify their applicability to the participant.

3. All bookings must be made in advance of the course start date. No bookings will be taken on the day of the course.
4. This Soccer Program is only designed for those who play soccer in a soccer club and are licensed in this club.
5. All courses, activities and venues are subject to change according to weather, programming and a satisfactory level of numbers. We may cancel any courses and/or change any information given, should this be necessary for any reason.

11. The cost of any damage caused by you or any participant you have booked on the course to any property or facilities will be passed on to you.
